#### **Process:**

To confirm your name is on the list of Electors, or to obtain a copy of the Customary Election Regulations, please call the Electoral Officer at 780 984 9825 ([lternes@ljtprocorp.com](mailto:lternes@ljtprocorp.com)) between 8:30 am and 5:30 pm Monday to Friday.

You may also view the Elector's List and Regulation at the Swan River First Nation Administration Office during normal office hours.

Votes will be counted at the polling stations after the polls close. Members are welcome to attend the count at either polling station.

Electors must bring a valid Treaty Card or another piece of current picture identification to be allowed to vote.
